Only SIX art entries and ONE entry form accepted from each artist. You will NOT be able to change the title
or price entered after you have submitted the form. All work must be for sale. All work must be a majority of
white in color. The curatorial jury reserves the right to eliminate any work at their discretion.

TO ENTER: Mail, or Email this form, and your submissions by 11:59 p.m., Sept 12th, 2009. NO slides. Accepted email
submissions should not exceed 1G at 5" x 5" per email. The resolution must be high enough for the jury to clearly
see the work. Images submitted in the mail should be on a cd rom and have a high resolution in JPG form. Image
file should be labeled - First Name Last_Title of Piece. Printed photos are not accepted.

There is no specific maximum size restriction, however the gallery ceilings are 11' and 12'

You will need an additional copy of this form to attach to the back of your artwork. Please note that you will have
20 days after your name is posted on b.a.l.m.'s web site to deliver your artwork. Accepted artists will be posted
to the web site on Saturday, Sept. 19th, 2009. Your signature below indicates that you have read and agree to all
conditions of the "WHITE SHOW" exhibition as stated in this flyer. Entry forms without a signature will be
disqualified. Digitally typed signatures are considered as a hand signature and are acceptable.

ARTIST'S SIGNATURE (required)

The artist agrees to all stated terms & conditions, including that b.a.l.m or Signs of Life Gallery may reproduce his or
her image(s) for show promotion (invitation, web site, newsletter and newspaper or any other promotional application
for the "WHITE SHOW".

GALLERY SALES/AWARDS

The gallery takes a 50% commission of all sales with 50% going to the artist. Awards for work will be given for what
the jury considers to be deserving. Award amounts & quantity will vary at the sole discretion of the jury & committee.

LIABILITY

Every reasonable precaution will be taken to assure protection of selected work, but neither b.a.l.m. nor Signs of Life
Gallery assumes responsibility for loss or damage from any cause — including shipping. Works will be insured for the
duration of the show while on gallery premises. Any additional insurance including shipping will be the
responsibility of the artist. SHIPPING COSTS ARE THE RESPONSIBILITY OF THE ARTIST. Gallery will pack for return.
